Paperwork Reduction Act Statement





The Federal Aviation Administration Acquisition Management System (FAAAMS), including the Procurement Toolbox, includes certain prescribed forms (also called templates) for use in procurement. These forms in some cases closely parallel or duplicate forms already in use by other civilian agencies and the military agencies, but in other cases represent the distinctive needs of the FAAAMS. The forms facilitate more timely and cost effective acquisitions. They are also useful for contract awards and administration. There are 79 forms. Each form is electronically retrievable within the FAAAMS FAST system. The forms used are required by statute, policy or implementing guidance. The information is essential for the proper function of the FAAAMS. The estimated average response time ranges from one to 64 hours per response depending upon the form. FAA protects confidentiality and proprietary information where necessary. An agency may not conduct, or sponsor, and a person is not required to respond to a collection of information unless it displays a currently valid OMB control number. The control number assigned to this collection is 2120-0595.
