A. Justification:

The U.S. Department of Homeland Security (DHS), Immigration and Customs Enforcement (ICE) is improving community safety by transforming the way the Federal government cooperates with state and local law enforcement agencies via the Secure Communities initiative. To maintain Secure Communities, ICE must continue to collect detailed requirements and input from its state and local law enforcement partners to focus resources on assisting all local communities in the removal of high-risk criminal aliens as authorized by 8 USC §1231, *Detention and Removal of Aliens Ordered Removed*.

- 2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.**

The data collected on this form is used by ICE to determine the fingerprint procedures and technological capabilities of state and local jails, governance, and basic jail booking statistics. This information will be used to prioritize and inform the strategy of the Secure Communities plan.

Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g., permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.**

A review of the Forms Inventory Report revealed no duplication of effort, and there is no other similar information currently available which can be used for this purpose.

This collection of information does not have an impact on small businesses or other small entities.

Secure Communities is a high level priority of the Department and Congress. Failure to implement the program will result in the failure to remove criminal aliens from the United States. The information only needs to be obtained during the initial phase of the program implementation.

7. **Explain any special circumstances that would cause an information collection to be conducted in a manner:**

- **Requiring respondents to report information to the agency more often than quarterly;**
- **requiring respondents to prepare a written response to a collection of information in fewer than 30 days after receipt of it;**
- **requiring respondents to submit more than an original and two copies of any document;**
- **requiring respondents to retain records, other than health, medical, government contract, grant-in-aid, or tax records for more than three years;**
- **In connection with a statistical survey, that is not designed to produce valid and reliable results that can be generalized to the universe of study;**
- **requiring the use of a statistical data classification that has not been reviewed and approved by OMB;**
- **that includes a pledge of confidentiality that is not supported by authority established in statute or regulation, that is not supported by disclosure and data security policies that are consistent with the pledge, or which unnecessarily impedes sharing of data with other agencies for compatible confidential use; or**
- **requiring respondents to submit proprietary trade secret, or other confidential information unless the agency can demonstrate that it has instituted procedures to protect the information's confidentiality to the extent permitted by law.**

There are no special circumstances applicable to this information collection.

There are no assurances of confidentiality provided to the respondents for this information collection.

The projected hours per response for this collection of information were derived by first breaking the process into three basic components:

Learning about the Law and the Form: 5 Minutes
Completion of the Form: 10 Minutes
Assembling and Filing the Form: 5 Minutes
Total Hours per Response: 20 Minutes

Annual Reporting Burden

Total annual reporting burden hours is 2,334. This figure was derived by multiplying the number of respondents (7,000) x frequency of response (1) x (0.3333333333333333) hours per response.

Annual Cost Burden

The estimated annual cost burden is \$ 23,340. This estimate is based on the number of respondents (7,000) x number of responses (1) x hours per response (0.3333333333333333) x (\$10) average hourly rate;

Government Cost

The estimated cost of the program to the Government is calculated by subtracting the Total Cost of Program from the Fee Charge. Total Cost of Program is calculated by the estimated number of respondents (7,000) submitting the IDENT/IAFIS Interoperability Local Law Enforcement Agency Survey, multiplied by (.5) hours (Time required to collect and process) x \$40 (Suggested average hourly rate for clerical, officer, and managerial time with benefits, plus a percent for the estimated overhead cost for printing, stocking, distributing and processing of this form).
