

## **SUPPORTING STATEMENT**

### **Justification for:**

PD F 2066, " Application by survivors for payment of bond or check issued under the Armed Forces Leave Act of 1946, as amended."

- 1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection.** Veterans of WWII were issued bonds or checks as compensation fro leave accrued during the war. Survivors of a deceased veteran may apply for proceeds due the deceased.
  
- 2. Indicate how, by whom, and for what purpose the information is to be used.** Used by the lawful survivors of the deceased veteran to identify the securities involved and to request payment. Without the information, the transaction cannot be completed.
  
- 3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology. What consideration is given to use information technology to reduce burden?**  
Public Debt has been a leader in e-Gov, providing the public with options for conducting financial transactions online for several years. To provide our customers additional options for submitting information electronically, we are taking the following steps: a technical project team is exploring options (such as pay.gov) and will select the mechanism(s)/infrastructure needed; concurrently, reengineering of business processes (and forms) is being conducted as the result of a reorganization of our major business lines.
  
- 4. Describe efforts to identify duplication. Why can't any similar information already available be used or modified for use for the purposes described in item 2 above?** Duplicate information is not requested.

8. **What effort was made to notify the general public about this collection of information?** The Bureau's notice was published in the Federal Register on September 25, 2009, Page 49071. No comments were received.
9. **What decision was made to provide any payment or gift to respondents, other than reenumeration of contractors or grantees?** N/A
10. **What assurance of confidentiality was provided to respondents and what was the basis for the assurance in statute, regulations, or agency policy?** In accordance with the Privacy Act of 1974, information furnished by the public is assured confidentiality.
11. **What justification is there for questions of a sensitive nature?** There are no questions of a sensitive nature.
12. **What is the estimated hour burden of this collection of information?** The average time needed is 30 minutes per response multiplied by the estimated number of responses (150) reflects the total burden of 75 hours.
13. **What is the estimated total annual cost burden to respondents or recordkeepers resulting from this**

**collection of information?** Estimated cost burden to respondents is not available.

**14. What is the annualized cost to the Federal Government?** The following factors were used to estimate the annual burden to this agency:

- a. Printing cost - estimated number of forms printed annually, multiplied by the unit cost of the forms.
- b. Case processing cost - estimated number of forms completed, multiplied by a percentage of the unit cost of case processing.
- c. Forms management cost - salary cost of forms management personnel.

Printing Cost	150 @ \$ .10	= \$	15.
Case Processing Cost	150 1.50/form	=	225.
Forms Management Cost		=	<u>500.</u>
Total Cost		\$	740.
