

**Focus Groups with SNAP Participants about
Farmers' Markets and Shopping Patterns**

 - Have shopped at a farmers' market between 0 and 2 times within the past one year
 - Half of whom are fluent in Spanish only; half of whom are bi-lingual and are comfortable participating in a Spanish-language group.

E1. Focus Group Recruitment Script -- English

FOR ALL GROUPS

- Mix of education levels. No more than 2 with an advanced degree; At least 5 with only some college or below; At least 2 with high school/GED or below.
- Mixed racial background (at least 3 non-White)
- Gender Mix. No more than 6 of one gender, if possible
- At least three individuals who are aged 65 or older
- At least three individuals who are parents of young children and receive WIC
- Only one person recruited per household.

What will the recruits be asked to do?

- Come to a community space (public library, meeting room in a community center) and participate in a discussion with about 10 other people;
- The group will last about 60 minutes.
- Participants will be asked about places in the community where they buy fruits and vegetables, their experiences using their EBT cards, the facilitators and barriers to shopping at farmers' markets, and their experience with any incentive programs.
- A light meal will be served prior to the group;
- Participants will receive \$60 at the end of the group.
