

## Supporting Statement for Paperwork Reduction Act Submission

Title: Transformation Initiative: FY13 Sustainable Communities Research Grant Program

### A. Justification

**1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.**

The purpose of this notice is to inform potential applicants that the Office of Policy Development and Research (PD&R) of the Department of Housing and Urban Development (HUD) is interested in receiving applications for grants to support research activities focusing on sustainability issues.

Grant applicants will be expected to submit the following information when submitting applications: Name, address, email address, employment history, Tax Identification Number, DUNS information.

Grantees are selected through a competitive process, announced through a Notice of Funding Availability. Applicants are required to submit certain information as part of their application for assistance. Grantees are required to prepare a quarterly status report so that HUD monitors the progress of grantees in completing their research.

**2. Indicate how, by whom and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.**

The information is collected during the application process. Collection of this data will serve two purposes:

- a) It will enable HUD to select grantee under a competitive selection process. Without this information, it would be impossible to determine which applicants to select.
- b) It will enable the Government Technical Representative (GTR) to monitor each grantee's performance. It is the only way to determine that funds are being spent in accordance with the goals of the program.

Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g., permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.**

Application materials will be submitted electronically via *Grants.gov*, and there is no impact on small businesses or any other entities.

**4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purposes described in Item 2 above.**

This program does not duplicate any existing government program. No similar information is available.

This program does not involve small businesses.

If information were not collected pursuant to submitting applications, HUD would have no qualitative way to select applicants to award among the various applications submit. If information were not collected for monitoring purposes, HUD would not be able to ensure that Federal dollars were being spent wisely and appropriately.

Information collected pursuant to submitting applications is requested only once per application cycle, the minimum amount of time possible. Information collected for monitoring purposes is submitted quarterly during the grant period. To require less frequent submission would mean that no action could be taken to correct administrative problems before the end of the grant period.

**7. Explain any special circumstances that would cause an information collection to be conducted in a manner:**

- requiring respondents to report information to the agency more than quarterly;
- requiring respondents to prepare a written response to a collection of information in fewer than 30 days after receipt of it;
- requiring respondents to submit more than an original and two copies of any document;
- requiring respondents to retain records other than health, medical, government contract, grant-in-aid, or tax records for more than three years;
- in connection with a statistical survey, that is not designed to produce valid and reliable results than can be generalized to the universe of study;
- requiring the use of a statistical data classification that has not been reviewed and approved by OMB;
- that includes a pledge of confidentiality that is not supported by authority established in statute or regulation, that is not supported by disclosure and data security policies that are consistent with the pledge, or which unnecessarily impedes sharing of data with other agencies for compatible confidential use; or

- requiring respondents to submit proprietary trade secret, or other confidential information unless the agency can demonstrate that it has instituted procedures to protect the information's confidentiality to the extent permitted by law.

**12. Provide estimates of the hour burden of the collection of information. The statement should:**

### **1) Pre-Award**

HUD estimates that each applicant spends approximately 35 person-hours to complete an application, excluding standard HUD forms. Almost all of this time is invested by a professor or other senior administrator who would oversee the program. HUD estimates the mean hourly rate at \$30. For 20 applications, the computation for burden hours is as follows:

$$20 \text{ applications} \times 35 \text{ hours} = 700 \text{ burden hours}$$

### **2) Post-Award**

HUD estimates that each grantee will spend approximately 6 hours a year maintaining records. HUD also estimates that each grantee will spend approximately 4 hours a year preparing monitoring reports. Clerical staff and faculty/supervisory staff will share this burden. HUD estimates the applicable hourly rate at \$15. The computation for burden hours is as follows:

$$5 \text{ grantees} \times 10 \text{ hours} = 50 \text{ burden hours}$$

$$\text{TOTAL BURDEN HOURS} = \text{Pre-Award Burden Hours (700)} + \text{Post-Award Burden Hours (50)} = 750$$

**13. Provide an estimate of the total annual cost burden to respondents or record keepers resulting from the collection of information (do not include the cost of any hour burden shown in Items 12 and 14).**

- \* The cost estimate should be split into two components: (a) a total capital and start-up cost component (annualized over its expected useful life); and (b) a total operation and maintenance purchase of services component. ### **1) Pre-Award**

HUD estimates that each applicant spends approximately 42 person-hours to complete an application. Almost all of this time is invested by a professor or other senior administrator who would oversee the program. HUD estimates the mean hourly rate at \$30. For 20 applications, the computation for cost estimate is as follows:

$$20 \text{ applications} \times 42 \text{ hours} \times \$30 \text{ per hour} = \$25,200.$$

### **2) Post-Award**

HUD estimates that each grantee will spend approximately 6 hours a year maintaining records. HUD also estimates that each grantee will spend approximately 4 hours a year preparing monitoring reports. Clerical staff and faculty/supervisory staff will share this burden. HUD estimates the applicable hourly rate at \$15. The computation for cost estimate is as follows:

$$5 \text{ grantees} \times 10 \text{ hours} \times \$15 \text{ an hour} = \$750$$

$$\text{TOTAL ANNUAL COSTS} = \text{Pre-Award Cost Estimate } (\$25,200) + \text{Post-Award Cost Estimate } (\$750) = \$25,950$$

**14. Provide estimates of annualized cost to the Federal government. **1) Pre-Award.**

Approximately 20 applications are expected to be received annually. Each application goes through a threshold review which takes one hour to conduct. This review is conducted by **five (5)** persons, having an average grade of GS-14 at an **hourly rate of \$45.00**. Thus the annual review process takes approximately **225** staff hours. The computation is as follows:

$$20 \text{ applications} \times 5 \text{ persons} \times 1 \text{ hours} \times \$45.00 = \$4,500.$$

**2) Post-Award**

HUD will award approximately 5 grants pursuant to each annual Notice of Funding Availability. With annual reporting, HUD would receive 4 quarterly progress reports for each funding cycle, requiring a total review time of one hour per grant per report, for a total of hour. Assuming a GS-14 conducts the reviews, the cost is computed as follows:

$$1 \text{ hour} \times 20 \text{ reports} \times \$45.00 \text{ an hour} = \$900.$$

In FY10, the program consisted of a two-stage Notice of Public Interest (NOPI) process. For this year's program, we are offering a standard Notice of Funding Availability (NOFA).
