Probes:

 - Please describe key resources or tools your state used to guide the development of the evaluation plan.
 - Is the plan being implemented, or has it become a "shelf document"?
 - If your program does not have a current, written evaluation plan, what resources are needed to support the development of a plan?
2. How would you describe the level of evaluation being conducted by your program (e.g., little evaluation is being conducted, or extensive evaluation efforts are underway for multiple facets of your program)?
 3. Please share with the group whether you have evaluated your CCC program, plan, and/or partnership?

Probes:

- Did you work with an evaluation consultant or contractor?
 - What type(s) of evaluation is being conducted (process—focused on program implementation and immediate outputs, outcomes, or process and outcomes)?
 - What kind of methods did you use to evaluate these elements of your program (e.g., surveys, pre/post- tests or assessments, monitoring health data over time)?
 - How are evaluation results being shared?
 - How are evaluation results being used (e.g., inform program improvements and/or practice)
4. What factors have facilitated program evaluation efforts?
 5. What factors have challenged program evaluation efforts?

Now that I have a better sense of your programs' evaluation efforts, let's spend some time discussing the CCCB Evaluation Toolkit.
