p. 5, Section D		Added Instructions Text: <b>Unmanned Aircraft Systems (UAS):</b> Presidential Memorandum, <i>Promoting Economic Competitiveness While Safeguarding Privacy, Civil Rights, and Civil Liberties, in Domestic Use of Unmanned Aircraft Systems</i> , issued February 20, 2015, requires that State, local, tribal, and territorial government recipients of Federal grant funding for the purchase or use of UAS for their own operations have in place policies and procedures to safeguard individuals' privacy, civil rights, and civil liberties prior to expending funds. p. 6, Section F		Added Instructions Text: <b>Governing Body:</b> The term "governing body" is defined as the institution or organization that has direct budgetary oversight or fiscal/financial control over the requesting organization. For law enforcement agencies where the chief executive is popularly elected (e.g., Sheriffs) such requesting organizations must provide official written notice to, but are not required to obtain approval from their civilian governing body at least 30 days in advance of any request to acquire controlled equipment from the Federal Government.
p. 6, Section G		Added Instructions Text: <b>Regional Geographic:</b> The geographic size of the area supported by the regional sharing agreement should be given in square miles (sq mi).
p. 6, Section H		Added Instructions Text: <b>Authorizing Official:</b> The Certification Statement is to be completed and signed by the Authorizing Official for the grant recipient or applicant and not the sub-grant recipient.
