On successful submission, assign case number. Numbering convention is BA-L###-YY. Number resets yearly back to 001.

Follow same rules for internal business rule validation...

- Verify registration code is valid (exists, name and code match and not expired)
- Run names through watchlist
- Flag any licensing warnings (countries)
- Assign case based on USML category
