Declaration of Person Who Performed Repairs or Alterations

Justification

- 1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.**

The "Declaration of Person Who Performed Repairs or Alterations," as required by 19 CFR 10.8, is used in connection with the entry of articles entered under subheadings 9802.00.40 and 9802.00.50, Harmonized Tariff Schedule of the United States (HTSUS, <https://hts.usitc.gov/current>). Articles entered under these HTSUS provisions are articles that were in the U.S. and were exported temporarily for repairs or alterations. Upon their return, duty is only assessed on the value of the repairs performed abroad and not on the full value of the article. The declaration under 19 CFR 10.8 includes information such as a description of the article and the repairs or alterations; the value of the article and the repairs or alterations; and a declaration by the owner, importer, consignee, or agent having knowledge of the pertinent facts. The information in this declaration is used by CBP to determine the value of the repairs or alterations, and to assess duty only on the value of those repairs or alterations.

These requirements apply to the trade community who are familiar with CBP regulations and the tariff schedules.

- 2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.**

The information in the declaration is used by CBP to determine the value of the repair or alteration and assess duty only on the value of that repair or alteration. Without this information, importers would have to pay duty on the full value of the imported article.

Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g. permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.**

This declaration can be submitted and stored in the importer's files on ACE via the DIS.

This information is not duplicated in any other place or any other form.

This information collection does not have an impact on small businesses or other small entities.

Failure to collect this information would make it difficult for CBP to make an accurate assessment of duty on the value of the repairs or alterations.

This information is collected in a manner consistent with the guidelines of 5 CFR 1320.5(d)(2).

Public comments were solicited through two Federal Register notices published on June 22, 2017 (Volume 82, Pages 28503) on which no comments were received, and on August 29, 2017 (Volume 82, Pages 41040) on which no comments have been received.

- 9. Explain any decision to provide any payment or gift to respondents, other than remuneration of contractors or grantees.**

There is no offer of a monetary or material value for this information collection.

- 10. Describe any assurance of confidentiality provided to respondents and the basis for the assurance in statute, regulation, or agency policy.**

This collection is not affected by the Privacy Act and is not impacted by a PIA. A SORN for IIS, dated July 26, 2016 (Vol. 81, 48826) will be included in this ICR. No assurances of confidentiality are provided to respondents.

CBP requests submission of this declaration approximately one percent of the time, which is equal to about 204 submissions per year. However, the declaration must be prepared and kept in the importer's files if they use HTSUS 9802.00.40 or 9802.00.50. The declaration may be kept in the importer's files on ACE which removes the recordkeeping cost.

Public Cost

The estimated cost to the respondents is \$307,489. This is based on the estimated burden hours (10,236) multiplied by (x) the average loaded hourly wage rate for importers (\$30.04). CBP calculated this loaded wage rate by first multiplying the Bureau of Labor Statistics' (BLS) 2016 median hourly wage rate for Cargo and Freight Agents (\$20.15), which CBP assumes best represents the wage for importers, by the ratio of BLS' average 2016 total compensation to wages and salaries for Office and Administrative Support occupations (1.4762), the assumed occupational group for importers, to account for non-salary employee benefits.^{1,2} CBP then adjusted this figure, which was in 2015 U.S.

dollars, to 2017 U.S. dollars by applying a 1.0 percent annual growth rate to the figure, as recommended by the U.S. Department of Transportation's value of travel time guidance.³

13. Provide an estimate of the total annual cost burden to respondents or recordkeepers resulting from the collection of information.

OMB control number 1651-0076, Customs and Border Protection Recordkeeping Requirements accounts for any record keeping costs CBP imposes for commercial entry purposes, including those associated with this collection. There are no additional record keeping, capital, start-up, or maintenance costs associated with this information collection that are not already included in that information collection. To prevent double counting of these recordkeeping costs, we do not restate those costs here. See OMB control number 1651-0076 for more information.

This information can be uploaded into ACE via the DIS which will store the information and remove any recordkeeping cost to the public.

The estimated annual cost to the Federal Government associated with the review of these records is \$3,149. This is based on the number of responses that must be reviewed (204) multiplied by (x) the time burden to review and process each response (.25 hours) = 51 hours multiplied by (x) the average hourly loaded rate for a CBP Trade and Revenue employee (\$61.76)⁴ = \$3,149.

15. Explain the reasons for any program changes or adjustments reported in Items 12 or 13 of the Supporting Statement.

Administrative Support occupations (\$25.3575) divided by the calculated average of the 2016 quarterly estimates (shown under Mar., June, Sep., Dec.) of wages and salaries cost per hour worked for the same occupation category (\$17.1775). Source of total compensation to wages and salaries ratio data: U.S. Bureau of Labor Statistics.
