PURPOSE: This project is part of the ongoing effort to ensure the information architecture meets user needs. The initiative undertaken by OEOM Information Architecture and SBSE, specifically to understand and align architecture to the customers mental model for content organized within the Gig/Sharing Economy Tax Center.

Deliverables from this work will include analysis and recommendations report.

The study will be conducted as an online unmoderated first click survey. Users will select the area on the design where they expect to find pertinent information to complete tasks with a minimum of 10 users per audience category, 20 participants total.
