The Popcorn Promotion, Research, and Consumer Information Order provides that popcorn processors may nominate eligible popcorn processors to serve on the Popcorn Board. Popcorn processors of more than 4 million pounds annually are eligible to nominate and be appointed to the Popcorn Board. No more than one officer or employee of a processor may serve as a Board member at the same time.
