You must certify that you are a bona fide applicant taking this test to pursue a Foreign Service career. In order to do so, you must meet the requirements listed below. By checking the boxes, you are indicating that you understand and affirm you meet each eligibility requirement.

- I certify that I will be at least 20 years of age and no older than 59 on the date I submit my application.*

- I certify that I am a United States citizen.*

- I certify that I am available for worldwide assignment, including Washington, D.C.*

- I have not been previously separated from the Foreign Service under sections 607, 608, 610, or 611 of the Foreign Service Act of 1980, as amended, nor have I resigned or retired in lieu of separation under these provisions. In addition, I have not been previously separated for failure to receive a career appointment under section 306 of the Foreign Service Act of 1980, as amended, nor have I resigned or retired in lieu of separation under these provisions.*

- I have not been found unqualified for employment by a Department of State Final Review Panel within the previous two years.
Exception(s) include: A candidate for a Special Agent position with the Diplomatic Security Service and the decision to deny eligibility was based on the candidate's inability to fulfill the unique duties of that position.*

- I am a bona fide applicant taking this test to pursue a Foreign Service career and I understand, acknowledge and agree to the requirements outlined below.*

Non-Disclosure/Conduct Policy Statement:

- That the Foreign Service Officer Test (FSOT) is protected by U.S. copyright laws and that disclosure of FSOT content could result in civil liability, criminal penalties, cancellation of test results, or denial of employment.
- That I will maintain the confidentiality of the test content and not disclose, publish, distribute, reproduce and/or transmit any test material, in whole or in part, in any form or by any means (verbal, written, electronic, or mechanical), at any time or for any reason. That I will not participate in any systematic attempt to recreate the material by memory following the examination.
- That I will not obtain FSOT content (including questions and answers) from unauthorized sources.
- That the Department of State reserves the right to cancel or withhold test results and/or disqualify my application when, in its judgment, a testing irregularity occurs, including but not limited to candidate misconduct, plagiarism, and misrepresentation of material fact.
- That my application is valid for up to 10 months and that my eligibility to sit for the FSOT is limited to no more than once during this period.
- That, while there is no charge to take the FSOT, I will pay a non-refundable fee of \$72.00 for failure to cancel a test appointment at least 48 hours (two business days) before the test date or failure to show up for the scheduled test appointment.
- I understand that conduct that shows poor judgement and/or lack of discretion that may affect the State Department's ability to carry out its responsibility and mission is grounds to find me unsuitable for employment.

These provisions are consistent with and do not supersede, conflict with, or otherwise alter the employee obligations, rights, or liabilities created by existing statute or Executive order relating to (1) classified information, (2) communications to Congress, (3) the reporting to an Inspector General of a violation of any law, rule, or regulation, or mismanagement, a gross waste of funds, an abuse of authority, or a substantial and specific danger to public health or safety, or (4) any other whistleblower protection. The definitions, requirements, obligations, rights, sanctions, and liabilities created by controlling Executive orders and statutory provisions are incorporated into this agreement and are controlling.
