| <b>Who must comply?</b>                                       | Certified Cargo Standard Program-Canine (CCSP-K9) participants.   |
| <b>What is this collection about?</b>                         | This information collection requires a CCSP-K9 participant to maintain records demonstrating compliance with all statutes, regulations, directives, orders, and security programs that apply to the operations of a CCSP-K9 participant.  |
| <b>Where do I find the requirements for this information?</b> | Title 49 CFR, Part 1549.105(a); 74 Fed. Reg. 47672 (September 16, 2009).  |
| <b>When must information be submitted to the TSA?</b>         | Information must be submitted to TSA upon request or during a review of compliance with the program requirements through routine onsite inspections, assessments, and tests.  |
| <b>How is the information submitted?</b>                      | The information must be submitted in accordance with the regulations. CCSP-K9 participants may submit information to a TSA representative during a review of compliance or these entities may submit the information to a TSA representative by way of e-mail at <a href="mailto:3PK9aircargosecurity@tsa.dhs.gov">3PK9aircargosecurity@tsa.dhs.gov</a> . |
| <b>What happens when complete information is received?</b>    | TSA will determine compliance with the program requirements through routine onsite inspections, assessments, and tests by examining the records submitted by the CCSP-K9 participant  |
