The VET TEC Application form allows Veterans to apply for the Veteran Employment Through Technology Education Courses (VET TEC) pilot program. The form will exist solely online and will be accessible via the VA.gov website.

To be eligible for VET TEC, you need to be

- A Veteran with at least one day of unexpired education benefits, or
- A service member with 180 days or less left on active duty
