<p>The panel also recommends several areas for research, including validation of measures of sexual behavior and attraction and measures that incorporate “queer,” asexual, and other emerging identities; alternate wording for the “straight” response category; the utility of including community specific terminology in response options; performance within adolescent populations; and how proxy reporting affects data quality (Recommendation 3).</p>	<p>It is difficult to find response options that both comprehensively reflect LGBTQI+ identities and are universally understood [24], particularly for youth or young adults [2, 3, 8, 19, 30, 35, 37]. Therefore, it's important to test terminology with a broad range of respondents or rely on previously tested terminology.</p>			<p>These items were used to assess sexual orientation among a national sample of LGBTQ+ secondary students as part of the 2021 National School Climate Survey (NSCS).</p>
