

## Registration Options

Welcome to the online site for making sure that your Motor Carrier operation (truck and passenger carrier) is properly registered with the Federal Motor Carrier Safety Administration. Whether you need to register with us or make an update to an existing record, this site will help you get the job done.

All electronic transactions will require a valid credit card (American Express, Discover, Master Card, Visa.)

### New or Additional Registration

- ☐ I think I need to register with the FMCSA to get a NEW [USDOT number](#), [Operating Authority \(MC/FF/MX number\)](#), or [CT number \(Cargo Tank Facility\)](#).  
(If you don't have USDOT number, select this option, then "Continue" and the system will let you know).
- ☐ I need an additional Operating Authority to my existing [USDOT number](#).  
(If you already have USDOT number, and apply additional operating authority, then "Continue").

### Continue Filling Out Registration
