Authority: This information collection is authorized under the Magnuson-Stevens Fishery Conservation and Management Act (16 U.S.C 1801 *et seq.*), the High Seas Fishing Compliance Act, the American Fisheries Act, and the Atlantic Coastal Fisheries Cooperative Management Act.

Purpose: To manage U.S. fisheries, permit holders must submit trip-level electronic fishing reports (logbooks) at weekly intervals, or at shorter intervals if notified by NMFS, through NMFS-approved hardware and software. Information collected includes fishing location and effort, fish harvested and discarded, as well as socio-economic and other data.

Routine Uses: The Commerce Department will use this information to ensure compliance with the regulations at 50 CFR part 622.
