Agency Information Collection Activities; Proposals, Submissions, and Approvals: Request for Intervention, Longshore and Harbor Workers' Compensation Act

I am requesting for Letter of Credit from Office, on my behalf and this written statement of Consent, to allow for the Security Deposits under the Workers Compensation Program, the Longshore and Harbor Workers' Compensation Act and extensions, and the Exemption for all LS Applications, to secure payment of compensation and medical insurance carrier defaults on any of its obligations under LHWCA, regardless of the date the obligation arose and for my request for Information Pertaining to the CFINS Known Investor Program and Streamlining the Foreign Investment Review process, under the Foreign Investment Risk Review Modernization Act of 2018 related to the Le Monde Marine Services, Ltd, whose property and interest are blocked by OFAC. The Federal Technology Transfer Act of 1986 as amended, by enacting the Stevenson-Wydler Technology Innovation Act of 1980, by the Hamas and Other Palestinian Terrorist Groups International Financing Protect Act, will prevent Hamas successors thereof from accessing its international support networker prevent using goods, including medicine and dual acts of terrorism, including against Israel, and imposition of sanctions with respect to foreign persons supporting Acts of Terrorism or Engaging in Significant transactions with Senior Members of Hamas and other Palestinian terrorist organizations. This will allow the United States to invest in human capital, facilitate entrepreneurship and innovation, strengthen the economic infrastructure by proper joint ventures with U.S. citizens upon the implementation of Executive Order 12957, per the Secretary of the Treasury and the Secretary of State, the authority to impose on a foreign institution upon determining that foreign financial institution has in or after the Orders of August 23, 1988, knowingly conducted or facilitated any significant transactions for the sale, supply, or transfer to or from Oran of significant goods or services used in connection with a Sector of the Iranian economy specified in, or determined be the Treasury. I am requesting the Secretary of State to carry out Proclamation 8693 with the Secretary of Homeland Security and the Attorney General of DOJ, under the National Emergencies Act, the Immigration and Nationality Act of 1952, to allow law enforcement objectives and allows person's entry further important United States by enacting regulations on the suspension of Entry of Aliens Subject to U.S. Security Council Travel Bans and International Emergency Economic Powers Act sanctions. The International Fund for Agricultural Development, the North American Development Bank or any other international financial institution, so notified by Secretary of Treasury to the Secretary of Labor, for the National Emergency Declared by the Order, the Secretary may relegate any of these functions within the Department of Treasury, and All Departments and Agencies of the United States shall take appropriate measures within their authority to implement this Order, by the authority granted by law to the Director of the Office of Management and Budget.

I am also requesting the Secretary of the Treasury to implement the Omnibus Trade and Competitive Act of 1988, and shall consult with the Committee on Foreign Investment by a representative of the Secretary's request to be Chair person who shall have authority, exclusive of the heads of departments and agencies, after consultation with the Committee. I am requesting the Director of National Intelligence begin preparing the analysis required by the Act at any time including prior to

acceptance of this notice of a transaction, in accordance with otherwise applicable law. The President shall direct, the issuance of regulations to carry out provide for the imposition of civil penalties for any violation, including mitigation agreement entered into, conditions imposed, minimize paperwork burden, reporting terms, with the implant amendments for the International Emergency Economic Powers Act and the Hizballah International Financing Prevention Act as amended.
