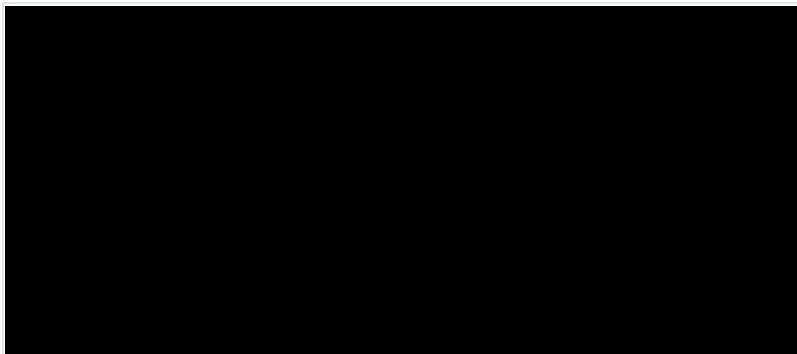

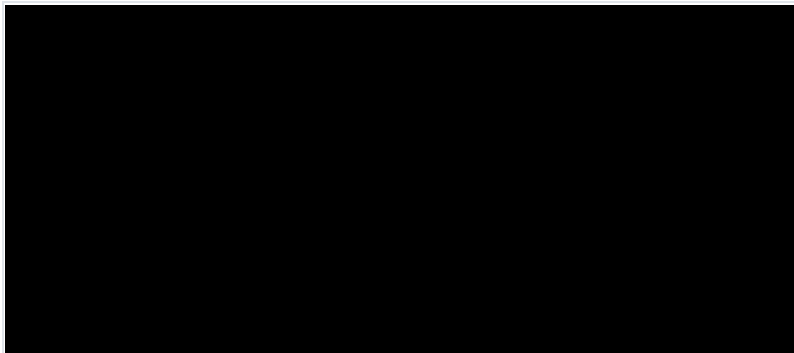

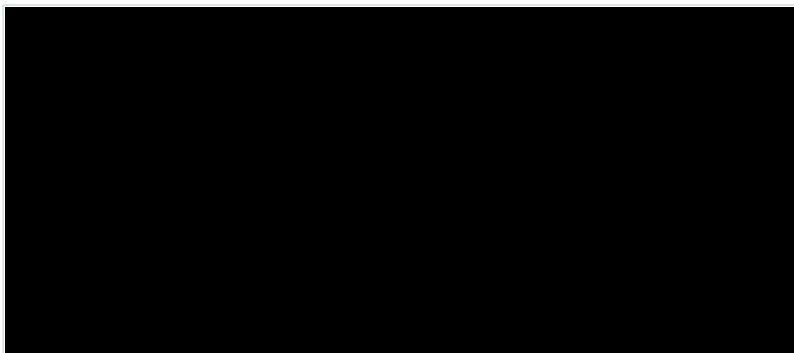

The nation's largest immigration reform group looks forward to working with him as he carries out President Trump's mass deportation mandate

WASHINGTON—The Federation for American Immigration Reform (FAIR) congratulates Sen. Markwayne Mullin on his nomination to be Secretary of Homeland Security. His nomination coincides with a strong [statement](#) by the newly formed Mass Deportation Coalition, of which FAIR is a member, urging President Trump to build on the successes of his first year in office by strengthening his efforts to deport people who are in the country illegally.

Sen. Mullin will be taking over leadership of DHS at a critical moment in history. The four years of the Biden administration saw the greatest wave of illegal immigration in American history. During his first year back in office, President Trump has overseen a successful effort to apprehend and remove the “worst-of-the-worst” of those who infiltrated our country.

There is much more to be done in terms of removing illegal aliens from the country. Our Constitution requires that our laws be carried out in a manner that promotes the general welfare of the nation. The presence of tens of millions of illegal aliens, filling jobs, utilizing public education and health care, and occupying affordable housing undermines the general welfare of the vast majority of Americans.

Sen. Mullin also assumes the helm of DHS at a time when our nation is at greatest risk of attack from terrorist sleeper cells than at any time since the creation of the department. They are hiding among the millions of other illegal aliens, adding to the urgency of fulfilling President Trump’s mass deportation mandate.

“A broad coalition of Americans stand ready to support Secretary nominee Mullin as he brings all of the resources of DHS to the task of large-scale deportation of illegal aliens,” said Dale Wilcox, executive director and general counsel of FAIR. “The presence of tens of millions of illegal aliens in this country was the result of a “Whole of Government” failure to promote the general welfare of the American people. We strongly urge the administration and the new secretary to take a “Whole of Government” approach to deport illegal aliens and encourage millions more to leave on their own.”
