Informed Consent

Purpose of this Survey

You are invited to participate in a survey about your resettlement experience in the United States. The purpose of this survey is to better understand refugees' experiences during resettlement and identify ways to improve services and support for future arrivals.

Your responses will help inform improvements to resettlement programs and policies.

What Participation Involves

If you choose to participate, you will be asked questions about:

- Your resettlement experience
- The support you received during your first 90 days
- Your current life and challenges
- Your hopes for improving resettlement for future arrivals

The survey will take approximately **10–15 minutes** to complete.

Voluntary Participation

Your participation is voluntary. You may choose not to answer any question, and you may stop the survey at any time without any penalty or loss of benefits.

Legal Authority to Conduct the Survey

The Welcoming Initiative for Newcomers is authorized to conduct this survey on behalf of the Office of Refugee Resettlement, Administration for Children and Families, U.S. Department of Health and Human Services, under The Refugee Act of 1980 (8 U.S.C. 1522).

Privacy

ORR will handle all information in accordance with applicable Federal privacy laws and requirements. This survey is **not anonymous**. Some information you provide (such as state of resettlement or general background information) may be linked to your responses.
